

Disaster Preparedness Network Nepal (DPNet-Nepal)

Nepal faces varieties of hazards, which combined with the growing population low level of education, preparedness and awareness, has made it one of the highly disaster prone countries in the world. According to UNDP/BCPR study (UNDP-2004), among 200 countries, Nepal stands at 11th and 30th position respectively with regard to relative vulnerability to earthquake and floods risk. Nepal is exposed to several types of disasters such as floods droughts, cold waves. landslides, earthquakes, wind storms, avalanches, debris flow, Glacial Lake Outburst Floods (GLOFs), cloudburst, hailstorms, fires, epidemics, lightning (thunderbolts) and ecological hazards. Adverse effects of climate change have already added a new dimension and are a major issue in disaster management in Nepal. A wide range of physiological, geological, ecological, meteorological and demographic factors contribute to the disaster vulnerability of the country. Disasters have been adversely affecting the sustainable development of the nation. Existing disaster management activities in the country are primarily focused on dealing with impact of disasters rather than addressing underlying risk factors.

Thus, a sustained partnership among all concerned organizations, stakeholders and individuals through the forum like DPNet-Nepal, would demonstrate an exemplary model of coordinated comprehensive disaster risk management system in Nepal.

PROFILE

DPNet-Nepal is a service oriented and nonprofitmaking forum established in 1996 as an independent and loose network of mainly organizations and individuals of both government and non-government sectors and United Nations Agencies involved in disaster management and disaster risk reduction activities in Nepal. The DPNet acquired legal recognition on 8 June 2007 under the Organization Registration Act 2034 BS. The Secretariat of DPNet-Nepal is in the premises of Nepal Red Cross Society, National Headquarters, Kalimati, Kathmandu. Since its establishment in 1996, the Secretariat of DPNet-Nepal has been hosted by NRCS.

OBJECTIVES

- Enhance co-ordination, co-operation and collaboration among local, national and international stakeholders.
- Enhance and build capacity of the organizations, individuals and concerned stakeholders on disaster risk reduction.
- Advocate for right based approach and inclusion to bring timely change in policy and practice so as to address the issues of disaster management system in Nepal.
- Promote knowledge, research, studies and disseminate data and information for the effective disaster risk reduction.
- Carry out other necessary activities as and when necessary related to disaster management.


