



Structural set-up for DRRM Governance



Decision Makers for DRRM

<u>Federal:</u> The Government of Nepal (cabinet), National Council for DRRM, Executive Committee for DRRM, National Disaster Risk Reduction and Management Authority, Concerned Ministries, Commissions, Security Agencies, Departments, and Concerned Offices.

<u>Province:</u> Provincial Government, Provincial Council for DRRM, Provincial Disaster Management Executive Committee, Ministries, and Concerned Offices.

<u>District:</u> District Disaster Management Committee, Chief District Officer, Security Agencies, District-based Concerns Offices.

<u>Local Level:</u> Rural/Urban Municipalities, Local Disaster Management Committee, Ward Disaster Management Committee, Local Level Concerned Offices.

Engagement at Federal and Provincial Levels

Federal Level:

- Executive Committee for DRRM: FNCCI, Chamber of Commerce, NRCS, Social Welfare Council, Nepal Scouts
- > NDRRMA: Program partnership and support, NPDRR
- Concerned Ministries, Commissions, Security Agencies, Departments, and Offices: Program partnership and support

Provincial Level:

- Provincial Disaster Management Executive Committee: As per concerned provincial DRRM laws
- Concerned Ministries, Commissions, Directorates, Offices: Program partnership and support

Engagement at District and Local Levels

District:

- District Disaster Management Committee: NGO Federation, FNJ, NRCS
- > Chief District Officer: Program partnership and support through the DEOC
- Security Agencies: Program partnership and support
- District-based Concerns Offices: Program partnership and support

Local Level:

- Rural/Urban Municipalities: Program partnership and support
- Local/Ward Disaster Management Committee: As per concerned local DRRM laws
- Local Levels Concerns Offices: Program partnership and support
- > Community strengthen and volunteers' mobilization for DRRM

Supporting for DRRM

Decision making:

- Participation at the concerned Committees for DRRM
- Activation of NPDRR, PPDRR at provinces, and LPDRR at local levels
- Advocacy and decision support for DRRM

Program partnership:

- Aid Mobilizations for disaster risk reduction: based on the provisions of the Standards for Aid Mobilization to the Provinces and Local Levels
- Program partnership and institutional support for disaster resilience

Working together for DRRM

- Risk Reduction
- ➤ Planning process of DPRP, LDCRP,
- Humanitarian support:
 - Early response
 - Emergency operations
 - Live saving activities
 - Relief distributions
 - Cluster activation
- Recovery, Rehabilitation and Reconstruction

Challenges

- Provisional: Lack of provisions and having few policy dilemma.
- Institutional: Very few/non representatives at the Councils, committees and institutional decision support system.
- Operational:
 - Lack of delineation of roles and responsibilities within three tiers of government.
 - Local Administration Vs Local Governments
- Behaviors: Hesitation to working together with Non-Governmental Stakeholders.

Way forward

- Formulate policy provisions as required.
- Avoid jurisdictional zig zag.
- Delineate of powers between three tiers of government.
- Collaborate with academia, media, CBOs, volunteers.
- Mobilize humanitarian agencies.
- Establish system of situation tracking, monitoring and getting feedback.
- Working together among government, non-government, private sector for DRRM.
